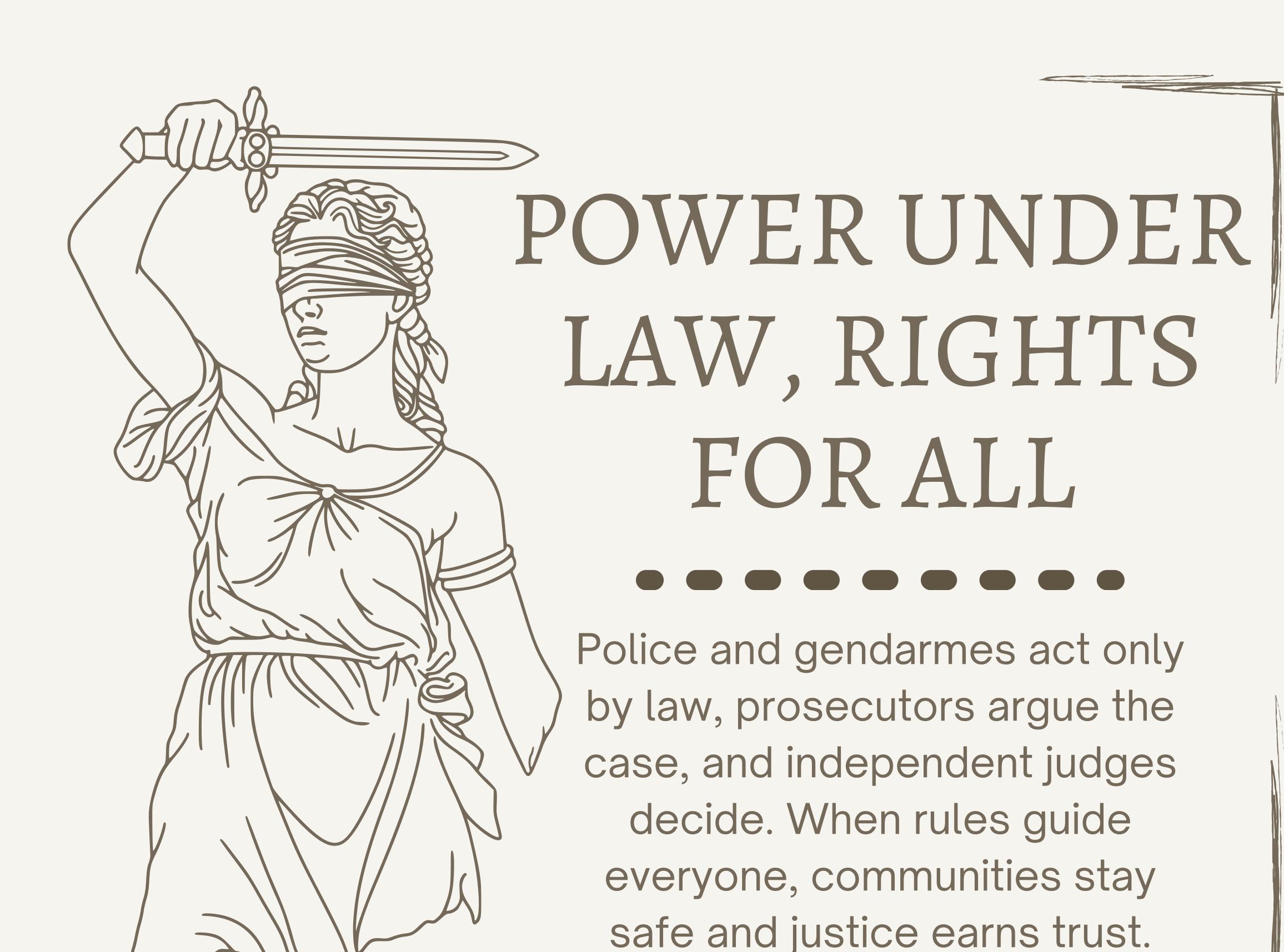

WHAT YOU'LL LEARN IN THIS CHAPTER

In this chapter, you'll explore who people of the law are and how they protect everyone's rights. From police officers and gendarmes to judges, prosecutors, and lawyers, each has a specific role in applying and defending the law. You'll see how institutions cooperate to ensure that power is used fairly and that no one is above the law. You'll also learn where citizens can turn when their rights are violated — from local authorities to international courts — and how legal professions demand both knowledge and integrity.

By the end, you should be able to explain how law enforcement, justice, and civic responsibility work together to keep society fair and safe.

HOW LAW ENFORCEMENT PROTECTS RIGHTS

TRUSTING THE LAW

WHY PROCEDURE, NOT POWER, GUIDES POLICING

When you meet police or gendarmes, their mission is not to intimidate, but to protect. They act under the law and every action must be justified and respectful. You have rights even when stopped or searched: to know why, to be treated with dignity, and to contact a parent or lawyer if you're a minor. Obeying lawful orders keeps everyone safe, but officers must also respect your freedom. Trust between citizens and law enforcement is essential to justice.

WHY WE TRUST JUDGES & PROSECUTORS

People need fair decisions — not personal opinions. Judges and prosecutors turn laws into justice. A judge listens to both sides, studies the evidence, and decides only by law, not by emotion. A prosecutor investigates crimes and represents the public interest — not revenge. Together with lawyers and clerks, they make sure that every trial respects truth, equality, and rights. That's why the law protects everyone, not just those in power.



The Judge

Hears all sides, checks the evidence, and delivers a decision based on law alone.



The Lawyer

Defends each person's rights — victim or accused — so justice can be complete.



The Prosecutor

Represents the state, gathers evidence, and asks for punishment only when facts prove guilt.

Judges

• Interpret laws and decide cases. They listen to both sides, check the evidence, and make rulings only according to the law, not to please the public or the media. Judges must stay independent, fair, and responsible.

Prosecutor



Prosecutors

Represent the state and the public interest.
 They gather facts and evidence, accuse those who break the law, and ask for penalties only when proof supports guilt.

Lawyers & Legal Aid

• **Defend citizens' rights** — whether the client is **accused** or a **victim**. Lawyers ensure everyone has a **fair chance** and that the law is applied equally. **Legal aid** helps those who can't afford a lawyer.

Clerks



Clerks

 Keep the official record of each hearing and make sure the court runs properly. Every word said in court must be recorded correctly that's how justice stays transparent.

Integrity in Justice

• Judges, prosecutors, and clerks must refuse gifts, pressure, or favoritism. Corruption—such as taking or giving bribes, or influencing a colleague—is a criminal offense. Reports go to the National Anticorruption Directorate (DNA).

INTEGRITY & INTERNATIONAL JUSTICE

A fair justice system depends on people who follow the law — not personal interests. Integrity means honesty, responsibility, and the courage to do what's right even when no one is watching. Romania's legal system protects citizens through strict rules for judges, prosecutors, and lawyers, and through cooperation with international courts when justice must go beyond borders.



INTEGRITY IN JUSTICE

Every judge, prosecutor, and clerk must respect the law, keep professional secrecy, and refuse gifts or advantages. Breaking these rules is corruption, punished by the National Anticorruption Directorate (DNA).



DISCIPLINE & ACCOUNTABILITY

The Superior Council of Magistracy (CSM) checks complaints against judges and prosecutors. When rules are broken, they can receive warnings, suspensions, or be removed from office. Discipline protects the credibility of justice.



RIGHTS & RESPONSIBILITIES

Citizens can report **corruption** or **misconduct**. **Integrity** is not only a duty for magistrates, but also a value for citizens who want a **fair society**.



INTERNATIONAL COURTS

If **rights are violated** and justice cannot be found in national courts, citizens can turn to the **European Court of Human Rights (ECHR)** or, in very serious cases, the **International Criminal Court (ICC)**.

These courts defend dignity, freedom, and peace among nations.

FROM COMPLAINT TO JUSTICE

Complaint

Anyone can file a complaint if they believe a law, judge, or institution has violated their rights.



Investigation

Institutions such as the DNA or Judicial Inspection verify if there is proof of wrongdoing. They collect documents, witness statements, and other evidences.



Disciplinary Action

If misconduct is proven, the CSM applies sanctions ranging from a simple warning to dismissal.



Public Transparency

Decisions of national or international courts are published publicly. This transparency shows citizens that no one is above the law.



Restoring Trust

After discipline or correction, institutions rebuild credibility through honest work, fair trials, and open communication.



So what for me?

Integrity starts with small actions — telling the truth, respecting rules, refusing unfair shortcuts. When you act fairly, you defend not just yourself but everyone's right to justice.

KEY CONCEPTS FROM LESSON 14

LAW ENFORCEMENT
Institutions like the Police and Gendarmerie maintain public order and enforce laws within communities.



PROSECUTION SERVICERepresents the public interest by investigating crimes and bringing offenders before courts.



JUDICIARY

Independent branch of justice — judges interpret laws, ensure fair trials, and protect individual rights.



LEGAL COUNSEL

Lawyers and legal advisers provide defense, representation, and legal guidance.



COURT CLERK (GREFIER)

Ensures accurate documentation of hearings, manages evidence, and maintains procedural integrity.



JUDICIAL INTEGRITY

Ethical duty of magistrates — to act with honesty, fairness, and independence from any influence.



DISCIPLINARY ACCOUNTABILITY

Mechanism ensuring that judges and prosecutors who break the law or ethics are investigated and sanctioned.



ANTI-CORRUPTION FRAMEWORK

Set of laws and institutions (like DNA) designed to prevent, detect, and punish corruption.



INTERNATIONAL JUSTICE

Includes bodies such as the International Court of Justice and the European Court of Human Rights — guaranteeing rights beyond national borders.



CITIZEN RIGHTS PROTECTION

Every person has the right to complain, to a fair trial, and to be defended by law, both nationally and internationally.
