# WHAT YOU'LL LEARN IN THIS CHAPTER

In this chapter, you'll see how the law defines identity and belonging. We start with civilstatus records — birth registration, name, and the Personal Numeric Code (CNP) — and how they prove who you are. You'll learn what ID documents (identity card, passport) are for and when you must show them. Then we explain citizenship: how it's gained (by parents, in limited birth cases, by naturalization), basics of dual citizenship, and how it differs from residence. We compare rights tied to citizenship (to vote, be elected, hold certain public roles) with universal rights. We also look at minorities, bans on discrimination, and people crossing borders — refugees, asylum, and statelessness. By the end, you'll be able to name the main identity records, explain how citizenship is acquired, and tell apart citizen-only rights from universal rights.

# IDENTITYINLAW

#### WHY OFFICIAL RECORDS PROTECT WHO YOU ARE

Your identity is recognized and protected by law from birth. The birth certificate proves your existence, your name, and family ties. Later, you receive a Personal Numeric Code (CNP) — unique for every person. These official records ensure your rights and prevent fraud. As you grow, ID documents such as the identity card and passport confirm your identity in daily life. Losing or misusing them can have legal consequences, so protecting your identity is also your responsibility.

### WHO HAS CITIZENSHIP?

Citizenship is your legal bond with a state. Most people get it by parents (at least one Romanian parent), while a few obtain it by birth in Romania in special cases (foundlings or children of stateless/unknown parents). Others can gain it by naturalization after lawful residence, clean conduct, and knowledge of the Romanian language and Constitution. Dual citizenship is allowed; inside Romania you have the same rights and duties as any citizen. Residence permits or refugee/asylum status let people stay, but do not confer citizenship.



#### By Parents (jus sanguinis)

A child is Romanian if at least one parent is Romanian, no matter the place of birth.



#### **By Birth in Romania**

Foundlings or children of stateless/unknown parents born here become Romanian.



### Refugees, Asylum & Residence

These give protection to stay, not citizenship. They can be a step toward naturalization later.



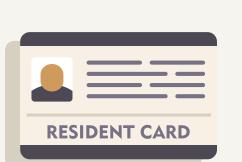
#### **Dual Citizenship**

Romania permits it. In Romania, the person is treated as a Romanian citizen with full rights and duties.



#### **Naturalization**

After legal residence, good conduct, means of living, and knowing Romanian & the Constitution; decided by the National Citizenship Authority.



#### **Loss or Renunciation**

Renunciation is possible if another citizenship is held. Born Romanians can't be stripped of citizenship; withdrawal can apply only to some naturalized cases.

# WHAT CITIZENS CAN DO & MUST DO

Civic



#### **Civic Rights**

- Vote & be elected Citizens shape government by voting and can run for public office.
- Petition & express opinions You may address authorities or protest peacefully to defend your rights.

Welfare



#### **Social Rights**

- Education & healthcare The state must guarantee free education and basic healthcare for all citizens.
- Social protection Support for vulnerable people, families, and those in need.

Economy



#### **Economic Rights**

- Work & fair pay Every citizen can choose a profession and has the right to decent working conditions.
- Property & enterprise Citizens may own property or start a business under the law.

Duties



#### **Civic Duties**

- Respect the law All are equal before it.
- Protect others & the environment Actions must not harm people, nature, or public goods.
- **Defend the country** Loyalty to Romania and the Constitution is a civic duty.
- Pay taxes Contributions fund public services and protect common welfare.

- Citizen = a person legally belonging to a state, with rights and duties.
- Equality before the law = everyone is treated the same.
- Civic participation = taking part in community or public life.

# ACTIVE CITIZENSHIP IN PUBLIC LIFE

A democratic society works only when its citizens take part in it. The law protects your right to participate, but it also expects responsibility and respect for others. Taking part means using your voice, vote, and actions to influence how your community is run. Whether you vote, sign a petition, join a consultation, or volunteer, every small action strengthens trust between people and the state.



#### **VOTING**

Through elections, citizens choose leaders at local, national, and European levels. Voting is both a right and a duty — it ensures that power reflects the people's will.



#### PETITIONS & CONSULTATIONS

Citizens can propose changes, express concerns, or ask public authorities to act. Petitions and consultations make sure authorities listen before deciding.



#### LOCAL PARTICIPATION

In your town or school, you can take part in youth councils, local debates, or civic projects. These help solve community problems and teach cooperation and accountability.



#### **VOLUNTEERING**

Helping others — through NGOs, campaigns, or community service — builds empathy and responsibility. Every act of participation shows that citizenship is active, not passive.

#### HOW YOUR VOICE BECOMES PUBLIC ACTION

## FROM VOICE TO IMPACT

#### **Get Informed & Ready**

Check your ID and polling place. You have a right to information—ask for public documents before decisions.



#### Raise an Issue

Use petitions or formal complaints to report local problems. Authorities must answer within legal deadlines.



#### **Have Your Say**

In consultations, send written feedback, speak at meetings, or join debates on budgets and rules.



#### **Choose Leaders**

Through elections, citizens pick representatives locally, nationally, and for the EU. You can also volunteer as an observer to keep the process fair.



#### **Hold Them Accountable**

After elections, attend council meetings, read reports and ask questions using access-to-information rules. Illegal or unfair acts can be challenged in court.



#### So what for me?

Your voice matters only if you use it. Staying informed, voting, and giving feedback keep democracy alive.

A responsible citizen doesn't stop after elections; they watch, question, and participate so that decisions reflect real needs.

### KEY CONCEPTS FROM LESSON 4



#### IDENTITY

Who you are — proven by official records such as your birth certificate, ID, and Personal Numeric Code (CNP).



#### CITIZENSHIP

A legal bond between a person and a state. It gives rights, duties and belonging to a national community.



**Acquiring Citizenship**Gained by parents, birth in certain cases, or naturalization after lawful residence, good conduct and knowledge of language.



#### DUAL CITIZENSHIP

Some states allow people to hold more than one citizenship. Rights apply within each country according to its laws.



#### RESIDENCE, ASYLUM & REFUGEE STATUS

These let a person stay lawfully and receive protection, but they do not confer citizenship.



#### RIGHTS OF CITIZENS

Civic, social, and economic rights — e.g., to vote and be elected, to education and healthcare, to work and own property — aimed at freedom and equality.



#### DUTIES OF CITIZENS

Obey the law, respect others and the environment, contribute through taxes, and take part in civic life.



#### ACTIVE CITIZENSHIP

Taking part in public life: voting, petitions, public consultations, community projects, and volunteering to improve the common good.



#### CONSTITUTION

A state's highest law. It organizes institutions, sets fundamental rights and duties and often defines national symbols.
